



## GARDEN OF ART

SCULPTURE EXHIBITION 2010

The River of Art celebrates the talent, creativity and natural beauty of the local region. It is grass roots, community driven festival, that will see a program of film, music, and visual arts, performance and literature throughout the shire over a ten day period between 21 and 30 May 2010.

The inaugural Sculpture Exhibition – Garden of Art -will be held at Greenland's Garden Centre, 89b Queen Street , Moruya.

Established and emerging artists from the Eurobodalla, Bega Valley and Shoalhaven shires are invited to present their works. Intending exhibitors should familiarise themselves with the following guidelines, terms and conditions.

### **TERMS AND CONDITIONS OF ENTRY**

#### **SUBMISSIONS**

Intending exhibitors are required to complete the application form and submit this together with the following information by 16 April 2010.

- a print ready digital image or drawing of the piece to be exhibited (Digital images may be used for promotional purposes for the River of Art in the future.)
- materials used and type of construction
- dimensions
- time of installation and any requirements of installation

#### **DESIGN**

Sculptural works will need to be of appropriate construction so as to not pose any risk to the safety of the public. The Selection Committee will consider all applications and their decision on which works will be accepted will be final.

#### **SITES**

Exhibitors should familiarise themselves with Greenlands environment and may wish to indicate a preferred location for their exhibit. If exhibitors wish to construct a sculpture for a particular site they are advised to collaborate with Tracey and Jeff Millikin by telephone 4474 0222 or email [greenlandsnursery@bigpond.com.au](mailto:greenlandsnursery@bigpond.com.au).



## **INSTALLATION AND DE-INSTALLATION**

All exhibitors will be responsible for the transport of their work to and from Greenland's. Exhibitors are responsible for all costs associated with manufacture, freight, installation, and insurance of the works. Greenlands will supply Public Liability Insurance cover for the works .

Installation will take place on 20 May from 9.30 am to 4.00pm. De-installation will take place on Monday 31 May from 9.30am to 4.00 pm.

Exhibiting artists will be responsible for the installation and de-installation of their sculptures.

If any proposed exhibit would require special equipment to put it in place or any special fixing, Tracey or Jeff Millikin, should be consulted at the earliest stage to see if this can be arranged. Telephone Greenlands 4474 0222

## **SALES**

Exhibiting artists are invited to price their work for sale.

Artists need to provide a laminated sign that can be secured at the site with the sculptural work that shows the artists name, title of work, price of work and any accompanying comments the artist would like to add. The size of the sign should be compatible with the work exhibited and its site.

The River of Art committee accepts no responsibility for damage to exhibits from any cause. It reserves the right to refuse entry to, or to remove, any exhibit which might be a public danger.

Exhibitors are responsible for all costs associated with insurance of their works.

**ENTRY FEE** is \$30.

A cheque or postal order, payable to River of Art Festival, must accompany the application.
